Dear Parents/Guardians,

We are excited to share our reopening plan with you. Thank you to all who have completed our survey. Since receiving guidance from our Governor, NYSED and the Department of Health, our team has developed a reopening plan that offers every student a choice of hybrid model of learning (in-person learning 2 days per week and distance learning instruction 3 days per week) or 100% distance learning (full-time distance learning with S-VE teachers delivering instruction remotely). Students enrolled in the hybrid model will be assigned to attend in-person on Monday/Thursday or Tuesday/Friday and will follow the distance learning model the other 3 days of the week.

In order to continue planning for your child(ren)'s education, we are asking you to select the preferred option for your child (hybrid model of learning or 100% distance learning) before noon on Monday, August 10, 2020. By reviewing our reopening documents and completing the Student Learning Enrollment Form, the district will be able to plan for staffing, cohorts, sanitization, technology, transportation and other logistics necessary to reopen and provide the safest, most equitable, and highest quality learning experience for students in September. We know circumstances may arise that may require you to adjust your child's educational plan; therefore, if you opt out from in-person instruction by choosing 100% distance learning, we will be reaching out monthly to confirm your child's educational plan.

Your input has been greatly appreciated thus far. We understand that this decision is challenging for parents and the mandates we are required to follow may not be what you had anticipated for reopening. We ask for your patience and understanding while we finalize the specific details. We will share all details with you as soon as we are able. The Governor is expected to make an announcement the week of August 1st regarding reopening schools. As we learn more, we will keep you informed. Thank you for your continued support.
